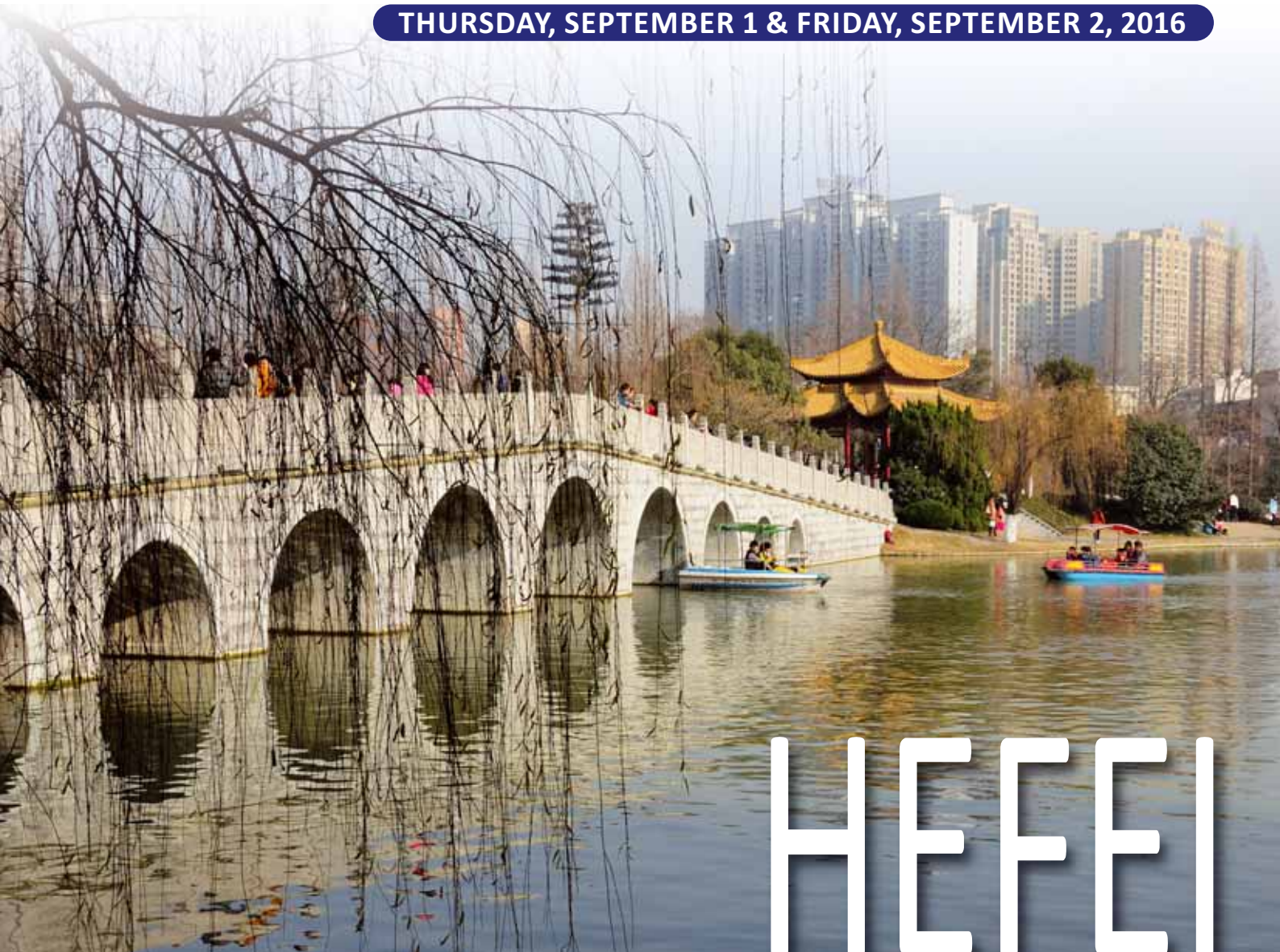

It will focus on **Homology of Medicine and Food: New Legislation and New Policy in the Era of Genes**. In addition to exploring theoretical and practical issues in modern medical technology, it will also discuss new opportunities and new challenges following by the 2015 Nobel Prize for Chinese traditional medicine.

- Advanced practices and new models in biopharmaceutical research and development
