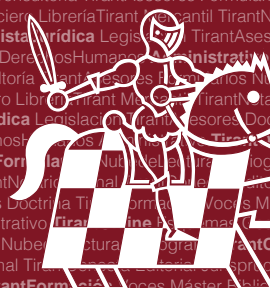

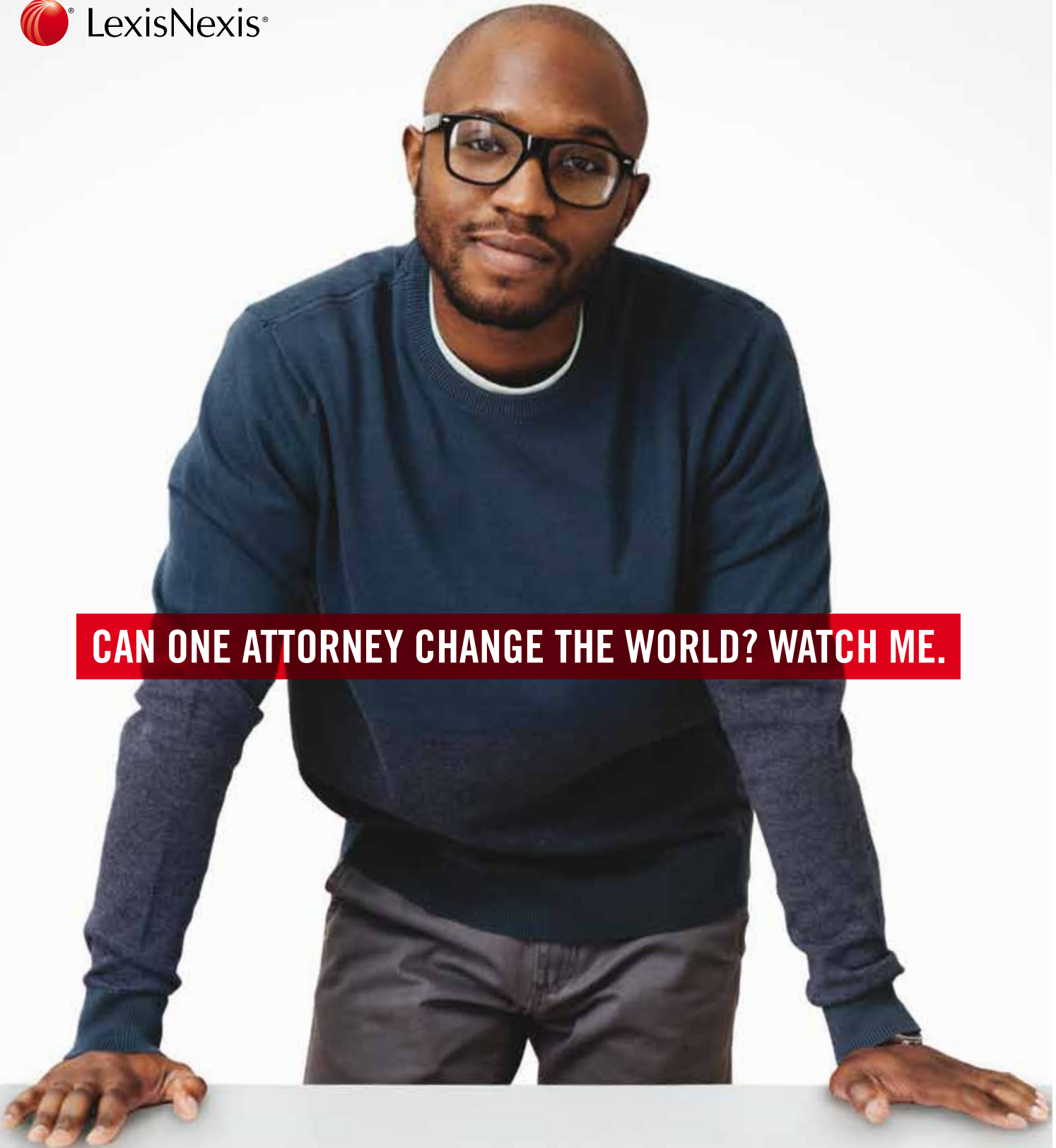

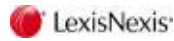

Competition law concerns have historically been a driving force in the regulation of distribution relationships: developments in fashion law have tested those regulatory limits as products entered new distribution channels. We will discuss how contract lawyers are developing new strategies for drafting and negotiating cutting-edge distribution contracts in the fashion and in other expanding industries in our challenging economies.
Insurance Law / Biotechnology Law / Health Law / Tort Law • Sala 2	<b>Risk Management, the Brain, and Lawyer Best Practices</b> Through biotechnology and developments such as brain mapping, the subject of personalized medicine applying to cognition has both benefits and challenges. Criminal Law • Sala 4	<b>The Growing Threat of Telephone Surveillance</b> There was a number of scandals last year, raising fundamental questions about the increasing threat of telephone surveillance. In France, the former President's telephone conversations with his lawyer were recorded and listened to, notwithstanding the fundamental basis of attorney - client privilege. In the UK, we have had a series of high profile criminal trials regarding phone hacking by journalists. In June 2014, the German Federal Prosecutor's office in Karlsruhe said it had uncovered sufficient evidence to probe whether U.S. spies had violated German law, in connection with the tapping of the Chancellor's mobile phone.

Environment Law and Sustainable Development ● Sala 5	<b>Insurance Against Environmental Damage</b>
Administrative Law ● Sala 6	<b>Expropriation of Ownership Rights – New Answers to Old Questions!</b> Expropriation is a recurring subject in the field of administrative law. It is a serious measure with serious, coercive ramifications for ownership. The Administrative Law commission will give the floor to specialized lawyers from around the world, who will explain the rules on expropriation in various countries, such as the applicable legal system, how the procedure is implemented, the indemnities to be paid and the legal remedies that exist. This session will provide answers to numerous comparative law questions.

Mergers and Acquisitions / Competition Law / Corporate Law / EU Law / Labour Law / Privacy and Rights of the Digital Person ● Auditorium 2	<b>Managing Legal Risks – Compliance and Beyond</b> It is trite to say today that “compliance matters”. Businesses understand the importance of implementing compliance programmes. But there is no “one size fits all” approach to building a compliance culture. During this panel, we will (next to our regular speakers) invite in-house counsels and external lawyers to discuss what is required for compliance efforts to be really successful. We will also try to answer an important question: Is compliance the universal solution to all problems? Or rather – do we need to go further than this and, if yes, what else can be done to eliminate or at least minimise the legal risks? The speakers will also focus on cross-overs of criminal law, employment law, corporate and privacy law implications for design and implementation of compliance programmes, especially in the context of internal investigations. Invited experts will present topics arising from the necessity to serve several conflicting requirements like protection of employees’ rights versus corporate interests, ban on self-incrimination versus obligation to cooperate, data protection versus forensic investigations, etc.
Private International Law ● Auditorium 3A	<b>Forum Selection Clauses in International Contracts</b> The designation of the jurisdiction and procedure that should govern the resolution of disputes is one of the first concerns when drafting a transnational agreement. However, the effectiveness of forum selection clauses is anything but self-evident; a number of cases have emerged worldwide in which courts have adopted a rather disdainful attitude towards dispute resolution agreements when in favour of foreign courts. Furthermore, the validity of unilateral option clauses, “carve-out” or multi-tier clauses and other complex dispute resolution provisions has been debated in various countries. During the session, we will focus on the trends in different legal systems as to choice of forum clauses, and we will provide an overview of the significant changes introduced by the coming into force of the Hague Convention on Choice of Court Agreements, together with its interaction with the recast of Brussels I Regulation.

The aim is to extend their network internationally for future engagements, to meet lawyers from around the world and to share their experience of managing law firms.
Media Law • Sala 3	<b>Can We Make Fun of Everything?</b> Can we legitimately curtail freedom of expression? Are humour, sarcasm and provocation part of freedom of expression? Are there risks in infringing the rights of certain persons or groups of persons?
Real Estate Law • Sala 4	<b>Acquisition of Property, Portfolio and Infrastructure</b> Valencia is a city recipient of infrastructures and Spain is a state with a “bad bank” in process of structuring the sale of portfolios of properties to foreign investors and where development is still stagnant. This makes Valencia a place to reorient our scientific work and add the tags “transactional” and “cross-border” to a very well nurtured work focused on development and on the relation of the individual and construction as art. The topic is broad but rather than covering all angles, we expect to have it land on small topics that allow to generate an exchange of thoughts, particularly on what an investor looks at and on the restrictions and limitations he may run across when attempting a “cross-border” acquisition of property or infrastructures.

## The Secrets of VALENCIA

### Did you know

that the first printed book in Spain was published in Valencia? It was in 1474 and in the Valencian language. It is entitled *Obres o trobes en lahors de la Verge Maria*.

### Did you know

that Valencia was the capital city of a great kingdom for more than four centuries?

Founded by King Jaime I in 1238, the Kingdom of Valencia persisted until 1707.



### Did you know

that Valencia hosts buildings designated World Heritage Site? The *Lonja de la Seda* (Silk Exchange) is the clearest example.



### Did you know

that Valencia has one of the oldest courts of the world? It is the *Tribunal de las Aguas de Valencia* (The Valencia Water Court), whose origins date back from the Muslim era, VIII-XIII centuries. Today it still takes place every Thursday at 12:00 pm at the Apostles Door of the Cathedral of Valencia.



### Did you know

that the Museum of Fine Arts in Valencia keeps a self-portrait by Velazquez? It was painted around 1640 and it is, along with Velazquez's own image in *Las Meninas*, the only self-portrait that has been preserved.



**Did you know** that Valencia has the largest aquarium of Europe? It is *L'Oceanogràfic*, located in the heart of the *Ciudad de las Artes y las Ciencias*.

**Did you know** that the Cathedral of Valencia was built over an old mosque? This mosque itself stood above the old Visigoth cathedral. **Did you know** that Valencia is one of the Spanish cities with more churches per capita? **Did you know** that one of the cups supposed to be the Holy Grail is kept in the Cathedral of Valencia? King Alfonso V would have brought it to Valencia in 1424.

Departure by bus at 9.00 am.

Játiva is 70 kilometres from Valencia, set in a landscape dominated by vines and cypress trees. It is a walled town built on a hill with two peaks. Játiva, which is dominated by the silhouette of its Collegiate Basilica, has a rich history and heritage.

The tour starts with a guided walk around the historic centre, including the Sant Francesc Church, Calle de Moncada, Plaça de Calixto III, the hospital, which is a national monument, and the Collegiate Basilica of Santa Maria of Játiva, which is the main religious building. You will then visit the Fine Arts Museum at Casa de la Enseñanza, where you can see works by José de Ribera, a native of Játiva. You will then take the tourist train, from which you can admire the magnificent landscapes on your way to the castle that overlooks the town. This has been designated a historic monument, and combines Roman, Gothic and Islamic architecture.

Around 2.00 pm, you will have lunch at one of the finest gourmet restaurants in the region, the Mont Sant, which is in an exceptional location, in a lush garden offering a breathtaking view on the village.



Return will be by coach in the middle of the afternoon.

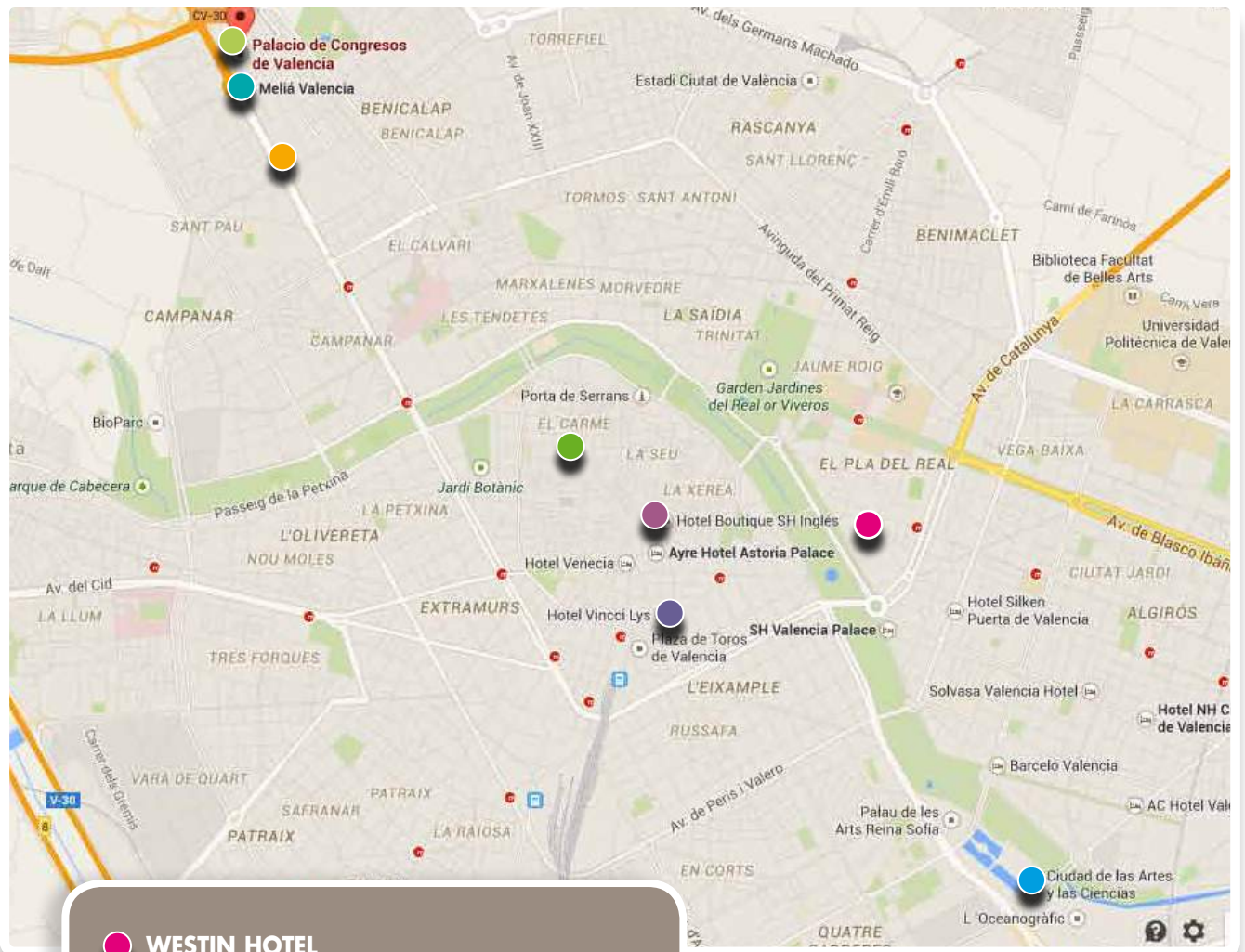
