In trade agreements such as the TCA, CETA, and the CAI, for which the EU and the People's Republic of China, recently concluded in principle the negotiations, provisions on dispute settlement are not of a merely ornamental nature, but form an indispensable part of the agreement. They typically provide mechanisms to resolve conflicts between the contracting parties. In addition, some trade agreements also provide mechanisms for investor-state dispute settlement. The speakers will discuss the various options and trends in regard of such conflict resolution mechanisms.

SESSION 3- Baby Boomer vs. Millennials- How to Mediate Multi-Generation Conflicts

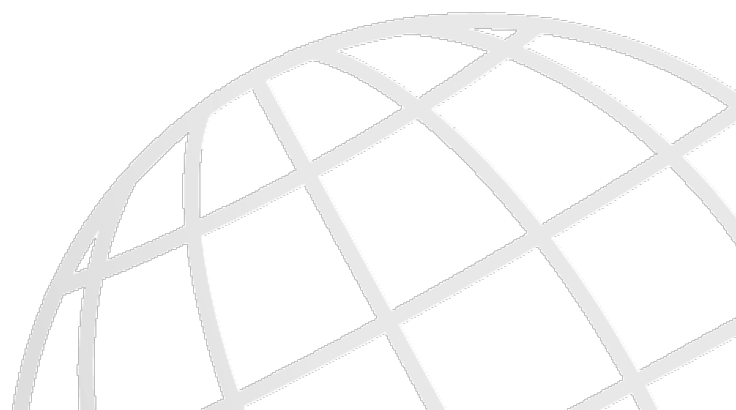
